NOTICE OF A SAN JUAN COUNTY PLANNING COMMISSION PUBLIC HEARING ON FRIDAY, JULY 17, 2020, AT THE COUNTY COUNCIL HEARING ROOM, LEGISLATIVE BUILDING, 55 SECOND STREET, FRIDAY HARBOR, SAN JUAN ISLAND BEGINNING AT OR AFTER 8:45 a.m. TO OBTAIN TESTIMONY ON AN ORDINANCE REGULATING MARIJUANA PRODUCTION AND PROCESSING FACILITIES; AMENDING SJCC 18.20.130, 18.30.030, 18.30.040, 18.30.460; AND ADDING NEW SECTIONS

The Planning Commission will take public testimony on the proposed marijuana production and processing development regulations.
