Thank you for adding your voice to the conversation. I am forwarding your letter to the Clerk to the County Council to add to the public record. Please note there will be a hearing on the matter during the February 23rd County Council meeting.

I understand your concern for public process. Vacation rental regulations were the single biggest issue I heard about during the campaign season. All of the candidates were asked repeatedly to take positions on a moratorium. Those positions were published in all the local papers and broadcast in the public forums at which we were invited to speak. The constituents I heard from were from every age group and walk of life, including Construction, Vacation Rental Management and Housekeeping, and Hospitality. The vast majority were very concerned about the impact of Vacation Rentals on their neighborhoods and wanted a moratorium, and preferably a cap, put in place immediately. All of this is to say, I am acting as I was asked to by the voters in this county and as I promised I would.

Please understand this does not mean your voice goes unheard. No one person can know the possible impacts of any decision on everyone who has a stake in that decision. Your input is much appreciated. Should we continue the moratorium, there will be town hall meetings and plenty of other opportunities for the public to voice concerns and suggestions. It is my hope this pause will allow for a conversation that results in regulations that are healthy for our neighborhoods, our islands, and our local economy.
