What is the Charter?

Section 1.30 - Construction

- > The power of the County shall be liberally construed; it is intended that this Charter confer the greatest power of local self-government on the people of San Juan County consistent with the State Constitution.
- Specific mention of a particular power or authority shall not be construed as a limitation on the general power of the County but shall be considered as an addition to and supplementary to or explanatory of the powers conferred in general terms by this Charter.

Creation of Climate & Environment Office and Elected Commissioner

Issue

San Juan County has had a difficult time prioritizing Climate Action and Environmental Protection due to numerous competing priorities on the County Council's agenda.

Proposal

The consolidation of existing staff, creation of an independently elected position solely focused on climate and the environment, being advised by a resident-led Advisory Committee will allow the County to take bold actions.

Declaration of Community Values

Issue

The existing Charter does not address the importance of fundamental values that should be upheld by the County Government concerning the well-being of the residents of the County and the natural environment they live within.

Proposal

Include language capturing the County's commitment to a diverse community, resilient economy, flourishing ecosystem, and sustainable environment.

Creation of Justice, Equity, and Inclusion Commission

Issue

SJC Resolution 31/2020 verbalized the County's commitment to a 'Safe and Inclusive Community'. Now is the time for the Charter to to create the structure that will make this a reality.

Proposal

Establish a San Juan County resident-led Commission to review and advise all elected and appointed county officials on matters regarding justice, equity, and inclusion.

Acknowledgement of the Relationship of Coast Salish People with the Land and Waters within San Juan County

Issue

San Juan County must acknowledge the First Peoples of these islands with honor respect.

Proposal

Include the following language in the Charter: "Let us acknowledge we reside on the ancestral lands and waters of the Coast Salish people who have called this place home since time immemorial and let us honor inherent, aboriginal and treaty rights that have been passed down from generation to generation."

Term Limits for County Council

Issue

The Charter Commission felt that term limits were appropriate for the County Council.

Proposal

- Set limits to three consecutive four-year terms
- Council Member can run again after sitting out one four-year term

Recommendations

- Tourism management plan, bringing Tourism Promotion into County, and use of Lodging Tax funds
- Enhanced elections observations
- 3. Membership and functioning of Law & Justice Council
- 4. Implementation of Community Values Declaration throughout government
- 5. Online County Records transparency
- 6. Maintenance of County Personnel System by resolution instead of ordinance
- 7. Exempt individuals abide by same personnel procedures as County employees.
- 8. Clarification of administrative departments under Manager
- Clarifying budget responsibility of the County Auditor
- 10. Online County budget access
- 11. County manager's deputy
- 12. Equitable and fair membership and appointments to resident committees.

Tourism Management Plan and Lodging Tax Funds

Issue

- County needs to complete tourism management plan.
- Community is concerned about the impact of tourism on the environment, scarce resources, and housing market.
- County could use lodging tax funds to support infrastructure and employee housing.

Recommendation

- County needs to establish a tourism management plan based upon accurate metrics regarding the economy and the environment
- Internalize marketing and promotion as a County government function.
- The County Council should prioritize the use of Lodging Tax Funds for seasonal worker housing and the protection and maintenance of existing tourism infrastructure (such as County Parks)

Membership and Composition of Law and Justice Council

Issue

Functioning of the Law and Justice Council of San Juan County can be more transparent, and the membership of the Council should be expanded to include residents.

Recommendation

Implement measures to increase the transparency and accountability
